4. *The data can be available to the organizer of the Competition - the Art Education Center, which is the co-organizers of the competition: Municipal Cultural Center in Głubczyce, Regional Museum in Głogówek, entities cooperating with the Administrator based on entrusted data processing agreements (ie hosting services - website maintenance) as well as entities based on the law.*
5. *The administrator does not plan to transfer data to third countries or international organizations, but it should be pointed out that the placement of personal data on the social networking site as Facebook may involve the location of presenting materials outside the European Economic Area.*
6. *Due to the commemorative and promotional purpose of sharing my child's personal data, the period of storage of this data is not specified;*

9. *Providing personal data is voluntary, however, due to the type and specificity of the competition that may entail the need to record performances by video and audio, the lack of consent for the child's image may make it difficult to take part in the competition.*
